SALARY AND COMPENSATION FOR ELECTED OFFICIALS FOR 2024

WHEREAS, Indiana Code Section 36-5-3-2 states the town legislative body shall fix the compensation of its own members, the Town Clerk-Treasurer, the Town Marshal and other town officers and employees.

WHEREAS, the Town Council and the Town Utility Service Board wish to establish salaries for the year 2024.

Therefore, be it ordained by the Town Council and Town Utility Service Board that the following salary schedule shall be in full force and effect on January 1, 2024, and the following stipend shall be in full force and effect upon passage of the ordinance. The ordinance reflects bi-weekly payroll amounts.

The Town will contribute \$500 per month toward a healthcare stipend for the Clerk-Treasurer. This stipend shall be made through the payroll system and deductions made in accordance with taxing authorities. This stipend shall not constitute compensation for purposes of Indiana Code Section 36-5-3-2.

The Town Council approves a one-time stipend to be paid in one installment by December 31, 2023, for the following elected officials in the following amounts:

Clerk-Treasurer \$7552.00

Such stipend shall not constitute compensation for purposes of Indiana Code Section 36-5-3-2.

This ordinance is adopted in compliance with the Indiana Code 36-5-3-2, mandating the town legislative body to establish salaries for town officials, officers and employees.

This ordinance shall be in full force and effect upon its passage, and the salary schedule shall be in full force and effect on January 1, 2024. Introduced on the First Reading on the 28 day of December 2023.
