ORDINANCE NO. 2024-11

**AN ORDINANCE AMENDING THE SOLID WASTE COLLECTION
AND DISPOSAL RATES TO ESTABLISH A REVISED FEE SCHEDULE**

WHEREAS, the Town Council of the Town of Dayton, Indiana, (hereinafter the "Council") has general supervisory powers over the services provided to the Town of Dayton, Indiana, (hereinafter the "Town") including solid waste collection and disposal;

WHEREAS, the Council, as part of its supervisory powers, establishes reasonable and just rates and charges for solid waste collection and disposal services;

WHEREAS, the Council has determined the current fee schedule for solid waste collection and disposal services no longer adequately reflects the expenses incurred by the Council for the provision of such service;


WHEREAS, the Council has determined that, due to the inconsistencies between the actual expenses incurred and the current fee schedule, such fees are not reasonable and just and should therefore be amended; and

WHEREAS, the Council has caused notice of a public hearing on the schedule of fees set forth herein to be duly advertised, posted, and mailed, and has held a public hearing thereon.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Dayton, Indiana, that Chapter 51 of the Town of Dayton, Indiana, Code of Ordinances, is hereby amended by adding the following provisions:

**SCHEDULE A
SOLID WASTE COLLECTION AND DISPOSAL RATES AND CHARGES**

Solid Waste Collection and Disposal Rates June 26, 2024, to June 30, 2025	\$14.25 per household	\$5.50 per additional wheeled container
Solid Waste Collection and Disposal Rates July 1, 2025, to June 30, 2026	\$14.25 per household	\$5.50 per additional wheeled container
Solid Waste Collection and Disposal Rates July 1, 2026, to June 30, 2027	\$15.00 per household	\$5.50 per additional wheeled container
Solid Waste Collection and Disposal Rates July 1, 2027, to June 30, 2028	\$15.75 per household	\$5.50 per additional wheeled container
